As many of you know, Tara Didi has been an integral part of our Ashram since 1976, which she joined after spending 32 of her formative years in Pondicherry under the direct guidance of the Mother.

On her birthday, July 5, we strive to find the right way to honour her. Her simple lifestyle and modest needs make it challenging to give her personal gifts.

This year Tara Didi will celebrate her 88th birthday. Interestingly, the special significance that The Mother has attributed to the number 8 is that it symbolises *“Double Enclosure (protection from inner and outer enemies).”*

Under Tara Didi's guidance, the focus of the Ashram has been to make a contribution to uplift the marginalised sections of society. This has been done by providing free education, boarding and lodging to the youth from underprivileged families in remote rural parts of the country, and by supporting through sponsorships, equipments and workshops, the education of children in rural areas where schools have very limited facilities.

As we can see, she has been working seamlessly and tirelessly in the field of Education to uplift the marginalised sections and to bring Innovation in Education. Her efforts were recognized by the Govt. of India in the form of honouring her with the Padma Shri Award in the year 2022. Her efforts are continuing with the same fervour and dedication, to this day.
